- 5.Electronic bids must be submitted through PPMO's e-GP systemwww.bolpatra.gov.np/egp on or before 12PM on 2080/12/02. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2PM** on **2080/12/02** at the office of **Department of Immigration**, **Kalikasthan**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **2,00,000** (**NRs. Two Lakhs only**), which shall be valid for 30 days beyond the validity period of the bid (i.e. **2081/03/28** / **12 July 2024**).
- 7.If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such cases the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
